In line with the administration's thrust to see the full implementation of Architecture Act of 2004 (R.A. 9266), the Committee on Legislation and Codes ("CLC") of the Commission on Governmental and External Affairs ("CGEA") is tasked to collaborate with our legislators for any possible support in the implementation of our law, and on all pending bills which has relation to the architecture profession. The Committee is also task to monitor all bills currently filed in the 18th Congress in relation to the amendments of RA 9266, RA 544, and the proposed Philippine Building Act.


