As a reminder, only members in GOOD STANDING with their CHAPTER DUES, and those who have paid their ANNUAL DUES before SEPTEMBER 30, 2018 with NO ARREARS are qualified to register. SLOTS ARE NON - TRANSFERABLE.

We will then verify the MEMBERSHIP STATUS via CHAPTER PRESIDENT and the MEMBERSHIP DIVISION of all of those who have registered and release a FINAL CONFIRMATION five (5) days after registration.

Once the registration has reached its' maximum number of 300 architects, the online registration will be stopped.
