### **GUIDELINES AND PROCEDURES ON AMNESTY PROGRAM**

The following are the guidelines and procedures on General Amnesty Program for Past UAP National Annual Membership Dues:

### 1. Coverage

All interested UAP Members who are delinquent in the payment of their UAP Annual National Membership Dues since membership with the UAP until Fiscal Year 2017-2018.

## 2. Implementation Period

The Amnesty Program shall be implemented beginning January 14, 2019 until June 29, 2019.

# 3. Procedure for Availing the Amnesty Program for UAP Annual National Membership Dues

- a. Fill-up the UAP General Amnesty Application Form (See Annex A). The form can also accessed at the UAP Official Website (www.united-architects.org)
- b. Submit the Form to your respective Chapter President for processing and payment of Chapter Dues.
- c. Submit the Form to UAP National Office as properly endorsed by the Chapter President.
- d. Pay the required dues pursuant to the table of payment.
- e. Receive the Membership Certificate from the UAP National for the Fiscal Year 2018-2019.

### 3. Terms and Conditions

- a. This program is made available to all UAP members who have arrears but have not availed of amnesty in the past. A member may avail of amnesty only once throughout his/her UAP Membership.
- b. The Amnesty Program shall apply to the UAP Annual National Membership Dues only.
- c. Those who will avail this amnesty may pay to their respective chapters including their chapter annual dues or must seek clearance from the chapter when payment will be made directly at the UAP National Headquarters.
- d. The UAP Membership Number of the delinquent UAP Member who availed this Amnesty Program shall be retained however will have a suffix of "0" after the UAP Number indicating that said member has availed the amnesty. Example: 12345-0
- e. The Membership Status of the delinquent UAP Member who availed the Amnesty Program shall start on the Fiscal Year 2018-2019.
