RESOLUTION ADOPTING REPUBLIC ACT NO. 9266, OTHERWISE KNOWN AS THE ARCHITECTURE ACT OF 2004

WHEREAS, the Twelfth Congress in its Third Regular Session, enacted Republic Act. No. 9266, entitled "AN ACT PROVIDING FOR A MORE RESPONSIVE AND COMPREHENSIVE REGULATION FOR THE REGISTRATION, LICENSING, AND PRACTICE OF ARCHITECTURE, REPEALING FOR THE PURPOSE, REPUBLIC ACT NO. 545, AS AMENDED, OTHERWISE KNOWN AS 'AN ACT TO REGULATE THE PRACTICE OF ARCHITECTURE IN THE PHILIPPINES,' AND FOR OTHER PURPOSES";

WHEREAS, Republic Act No. 9266, otherwise known as "The Architecture Act of 2004," is fully supportive of the policy of the state recognizing the importance of architects in nation building and development;

NOW THEREFORE, on motion by Sangguniang Bayan Member Joel F. Delos Santos, duly seconded, this Sanggunian HEREBY RESOLVES to adopt Republic Act No. 9266, otherwise known as the Architecture Act of 2004;
