The Execom decided that the Nomination and Election of officers shall be conducted online.

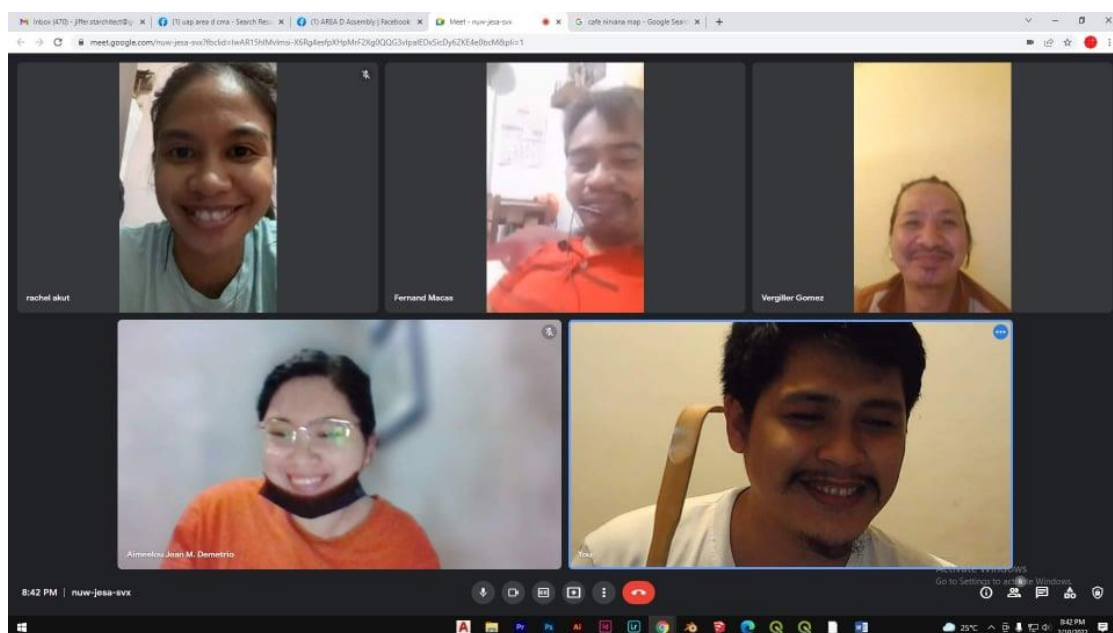


Figure 1 October 2021 Execom Meeting Attendees

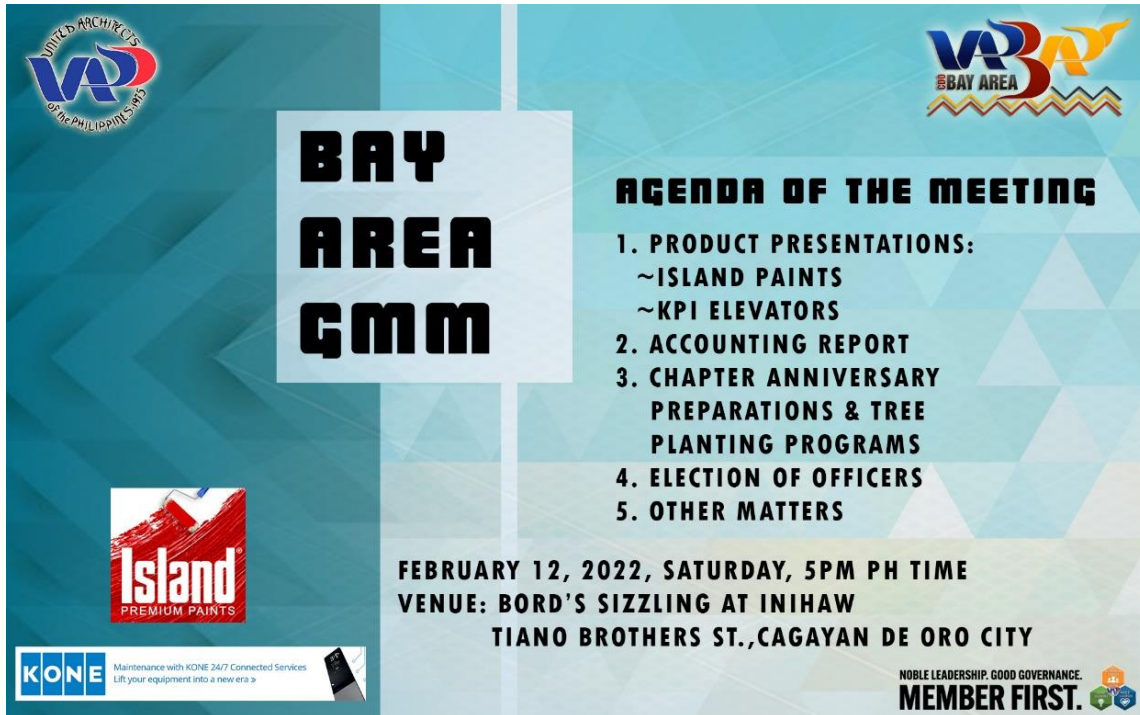


Figure 2 February GMM Poster

After the nominations, the Elections done Online through Google forms.

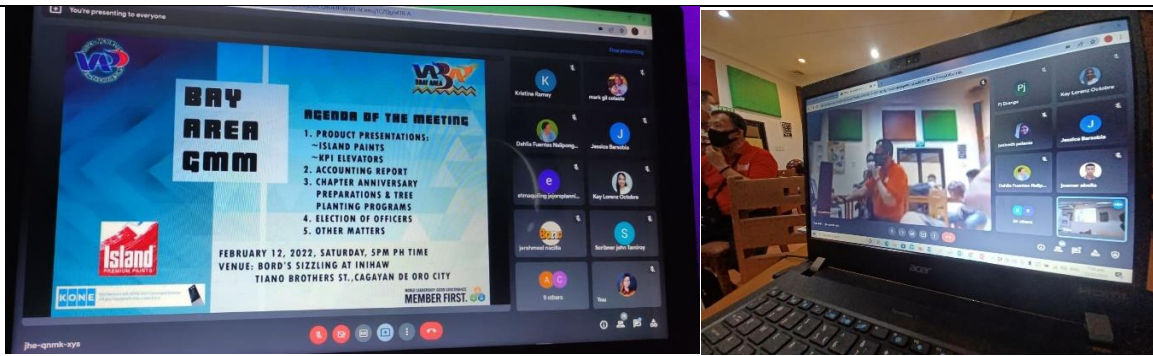


Figure 4 GMM Online Broadcast and Online Attendees
